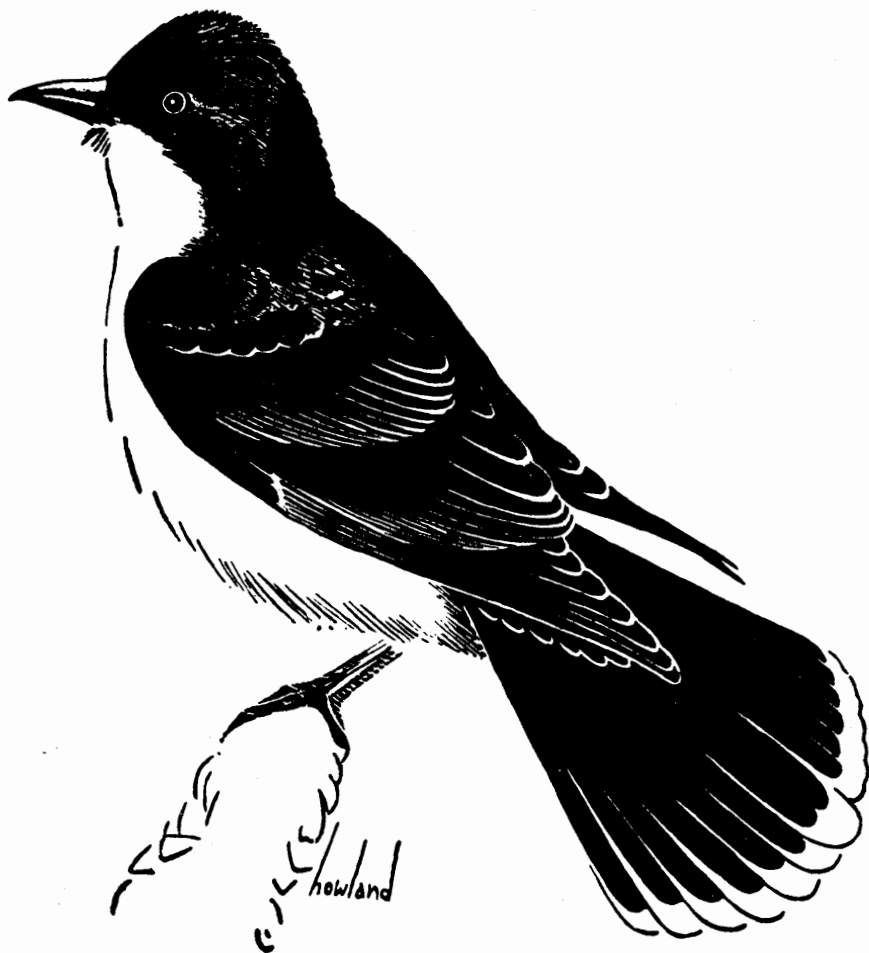

THE KINGBIRD, published four times a year (January, May, July and October), is a publication of The Federation of New York State Bird Clubs, Inc., which has been organized to further the study of bird life and to disseminate knowledge thereof, to educate the public in the need of conserving natural resources and to encourage the establishment and maintenance of sanctuaries and protected areas. Individual member's dues are \$8.00 annually. Other membership classes are: Family Membership (\$10). Supporting Member (\$15), or a Life Member (\$150)—“payable over a four-year period in equal installments,” if member so desires. Student membership \$3.00. *KINGBIRD* institutional subscriptions: \$9.00 per year on calendar year basis only. Single copies: \$2.25. All memberships are for the calendar year and begin with January of the year in which the member joins. Memberships beginning after the first of the year include back issues for that year.

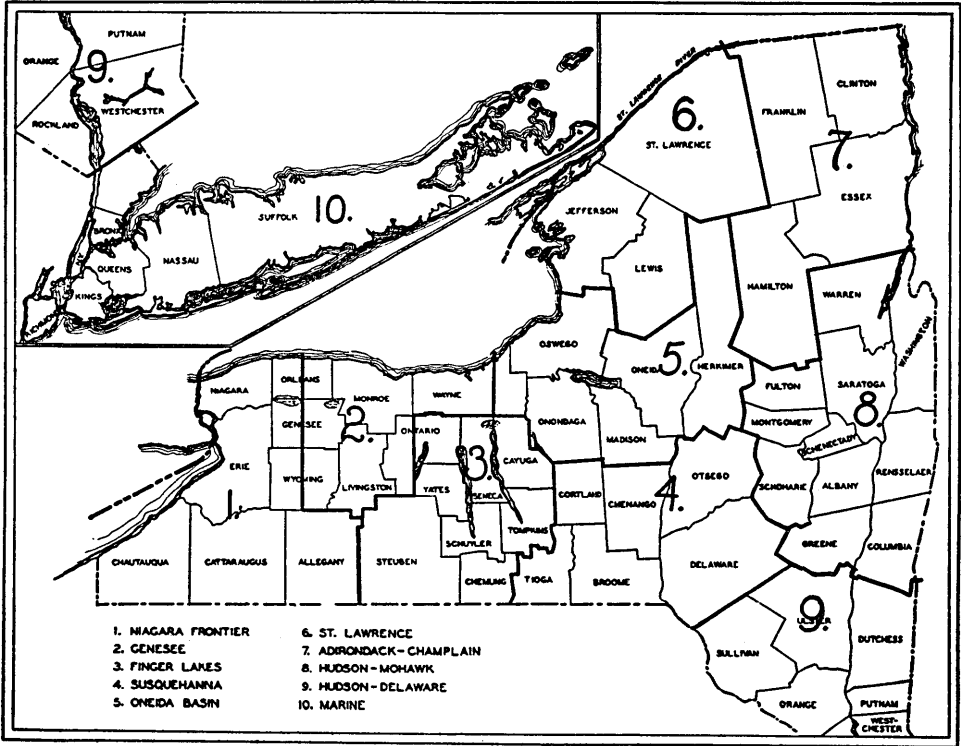
